Proposed Fee Schedule Revisions to include Microfilm and Scanning fees
Adopted 7-21-09; Effective 8/1/09

Lexington Wetland Protection Code, c. 130 – Fee Schedule

1. These fees are in addition to the fees paid pursuant to The Wetlands Protection Act, M.G.L. c. 131, s. 40.
2. All Requests and Notices filed pursuant to Lexington Wetland Protection Code, c. 130 shall be accompanied by a filing fee, the amount to be determined by fees adopted by the Lexington Conservation Commission, and a brief description indicating how the applicant calculated the fee.
3. Whenever the Conservation Commission determines that an inadequate fee has been paid, the time period for the Conservation Commission to act shall be stayed until the balance of the fee is paid.
4. If any of the activities are in a Riverfront Area in addition to another Resource Area or Buffer Zone, the fee per activity should be multiplied by 1.5 and then added to the subtotal amount (or add 50% to total fee).
5. Town Projects are exempt from Wetland Protection Code Fees.
6. Microfilm and scanning fees can be reduced by 70 % if electronic files (i.e. pdf, TIFF, AutoCAD, etc.) are provided in accordance with the town policy.

Notice of Intent (NOI)	G. Each minor addition to or accessory use activity covering an area less than 500 s.f. associated with an existing single-family or multi-family residential dwelling, including but not limited to additions to existing dwellings, swimming pools, athletic courts, driveways, sheds, decks, and landscaping	\$200.00; plus \$30.00 for microfilm and scanning fee
NOI	H. Each major addition to or accessory use activity covering an area equal to or greater than 500 s.f. associated with an existing single-family or multi-family residential dwelling, including but not limited to additions to existing dwellings, swimming pools, athletic courts, driveways, sheds, decks, and landscaping	\$400.00; plus \$60.00 for microfilm and scanning fee

NOI	I. Each new single-family dwelling, including associated driveway, utilities, grading, landscaping and drainage structures	\$800.00; plus all applicable fees listed in lines N through R of this chart as well as \$125.00 for microfilm and scanning fee
NOI	J. Each new multi-family dwelling	\$800.00; plus \$100.00 per unit located within any Resource Area or Buffer Zone; plus all applicable fees listed in lines N through R of this chart as well as \$125.00 for microfilm and scanning fee
NOI	K. Each subdivision roadway, other roadway, or non single-family dwelling driveway, and all associated drainage structures, utilities, grading, curbing, landscaping, and other associated work exclusive of dwellings or buildings	\$800.00; plus all applicable fees listed in lines N through R of this chart as well as \$125.00 for microfilm and scanning fee
NOI	L. Each minor commercial, industrial, institutional, or non-residential new construction or addition that is less than 500 s.f	\$500.00, plus all applicable fees listed in lines N through R of this chart as well as \$75.00 for microfilm and scanning fee
NOI	M. Each major commercial, industrial, institutional, or non-residential new construction or addition that is equal to or greater than 500 s.f	\$1,500.00, plus all applicable fees listed in lines N through R of this chart as well as \$250.00 for microfilm and scanning fee
NOI or Abbreviated Notice of Resource Area Delineation (ANRAD)	N. Boundary delineations for any resource area	\$1.00 per linear foot of Resource Area boundary, not to exceed \$200 for activities associated with single-family house or \$1,500 for all other activities
