
PROPOSED TRAIL SYSTEM OPTIONS



- + Creates a grand total of 1910 linear feet of accessible trails
- + Re-vegetates 130 linear feet of former trail; 90 linear feet of that is within the wetland
- + Unimproved trail is primarily in an upland area
- Adds boardwalk in 100' linear feet of previously undisturbed land

PROPOSED OVERLOOK OPTIONS









OVERLOOK OPTION A

- New structure, at intersection of paths
- Provides a central location
- No direct pond access
- Approx. size of 15'x10'
- Platform will obstruct the view of the pond from the main entrance path
- Can accommodate benches and an interpretive sign
- Will require 42" high guardrail
- Pondside location generally remains inundated, except in extreme dry periods
- Location gets more sun; Hot in summer, warm in winter
- May require more clearing of undisturbed area

OVERLOOK OPTION B

- Widens bridge as overlook
- Provides a more intimate location
- No direct pond access
- Approx. size of 15'x10'
- Preserves view of the pond from the main entrance path
- Can accommodate benches and an interpretive sign
